

FRANCESVILLE FALL FESTIVAL

SEPTEMBER 16, 17, & 18, 2011

The annual FRANCESVILLE FALL FESTIVAL, will be held in downtown FRANCESVILLE (on the street). We have a full schedule of free entertainment during the Festival. We advertise in all the surrounding communities and are listed in the Indiana Festival and Travel Guide.

Exhibits are open to all artists, craftsmen, flea markets, and trade booths. All general rules, (reverse side) apply to this Festival.

Booth spaces are 10' deep by 20' wide, outdoors, with improved electric facilities. Spaces are reserved upon receipt of reservation fee on a first/come/first served basis. Each 10 X 20 space is \$30 for all three days, **plus a \$30 deposit, which will be returned at 3:00 p.m. on Sunday to all booths that stay for Sunday) (We encourage a separate check for \$30, which will held until Sunday and then returned)** Electrical hook-up is \$15 for 110V, \$25 for 220V. Please indicate if you need more than 15 amp. Bring own electrical extension cords. All FOOD SALES pay 10% of total sales. FOOD BOOTHS require a \$25 deposit (only) with reservation, deposit will be applied toward the 10% gross at close of Festival. Pulaski County requires a food permit from the County Health Office. Food Booths please, pay at information booth at close of Festival. **FOOD BOOTHS ARE REQUIRED TO LIST ALL ITEMS THEY WILL BE OFFERING ON THEIR ENTRY FORM AND MUST BE ACCEPTED BY FESTIVAL COMMITTEE PRIOR TO THE FESTIVAL. INTERNATIONAL FIRE CODE 904 11. 62 STATES THAT HAZARD AREAS INCLUDE DEEP FAT FRYERS- - A CLASS K PORTABLE FIRE EXTINGUISHER MUST BE IN THE BOOTH AND HAVE AN INSPECTION TAG ON IT THAT INDICATES IT HAS BEEN INSPECTED WITHIN THE YEAR. ALL OTHER VENDORS MUST HAVE AN ABC TYPE EXTINGUISHER WITH THEM AND MUST NOT HAVE ANY SPLICED EXTENSION CORDS.**

Our booths are measured exactly 10' X 20' to fit our streets, if your booth does not fit into this size, we can make special arrangements, but this must be done at the time of reservation. No cancellation refunds after September 12, 2011.
